

The Dr. Paulette C. Walker Endowed Scholarship (PCWES) Fund was established in 2012 by the alumnae of Delta Sigma Theta Sorority, Epsilon Epsilon Chapter, following the chapters 50th Anniversary in 2011. The scholarship program is run through the Office of Financial Aid.
